This 10-week program is taught to the entire 6<sup>th</sup> grade class and promotes effective decision making stills, goal setting, and positive relationships. To learn more



The Dunbarton Police Department is pleased to offer a new community policing program: **Project Good Morning!** Project Good Morning is a program designed to assist community residents who do not have regular daily contact with relatives, friends or neighbors. The program allows for residents to make scheduled contact with the Dunbarton Police Department to ensure that they are OK, and further allowing for their independence and ability to stay in their homes. This program allows family, friends and neighbors the security of knowing the enrolled individual is having regular daily contact with someone.
