Evaluation Studies

Each Too Good evaluation study was conducted by third-party researchers and used randomized treatment-control group designs. Those researchers examined pre-test equivalence between treatment and control groups, potential bias of loss of student data over time, quality of program implementation, and estimates of reliability and validity of assessment tools.
